Dear Scholarship Applicant,

Thank you for your interest in a legislative district 43B House of Delegates Scholarship for the 2024-2025 academic year. This scholarship is available to students who live in legislative district 43B (verify your district at: http://mdelect.net) and will be attending a college, university, or private career school in Maryland. You may use the scholarship for an out-of-state school only if the Maryland Higher Education Commission (MHEC) identifies your major as "unique" (not currently available at any Maryland institution), or if you are a Maryland resident serving in the military and stationed out of state.

The scholarship may be used by undergraduate or graduate students, full-time or part-time. Full-time undergraduate students must maintain 12 credits or more per semester, while part-time undergraduates must maintain 6-11 credits. Full-time graduate students must maintain 9 or more credits per semester, while part-time graduate students must maintain 6-8 credits per semester. If attending a trade school, it must be approved to operate in the state of Maryland, and you must be enrolled in a minimum of 18 clock hours.

The Delegate Scholarship is for one year. You must reapply for the scholarship each academic year. Application packets are due no later than April 1, 2024, via mail or email to Delegate Catherine Forbes, District 43B, 6 Bladen St. Room 304, Annapolis, MD 21401 Catherine.Forbes@house.state.md.us. Applicants are responsible for verifying receipt of their application by our office.

Please include the following in your application packet:

- Application form
- Statement of 200 words or less as required on application form.
- Statement of 200 words or less explaining your financial situation (new applicants).
- One letter of reference (optional for renewing applicants).
- Copy of your most recent transcript or report card.
- Copy of the Student Aid Report (SAR) from your completed FAFSA.
- Proof of 43B residency (Maryland driver's license or Identification Card).

I have established a Scholarship Committee to facilitate a thorough review of all applications so that I may award as many scholarships as my budget allows.
